Recipients of your data are providers of e-mail services, IT solutions collecting data necessary for communication entities cooperating with the Personal Data Administrator for the purpose of processing your orders.

The Administrator uses due diligence to ensure that personal data is processed within the territory of the European Union and that it is stored in a manner that guarantees an adequate level of security. We do not process or outsource personal data to countries outside the European Union, and in the event that it would be necessary to do so, we will ensure that personal data will be processed only by entities that ensure the adequacy of protection to the standards adopted in the European Union.

Personal data will be kept as long as the Administrator conducts business, however, you may opt out of marketing communications at any time.

We respect each person's rights related to the processing of their personal data. In particular, each person whose data is processed has the right:

- (a) to be informed about the processing of his/her personal data,
- (b) the right to access, request rectification, completion and amendment of data,
- (c) the right to erasure of data ("right to be forgotten"),
- (d) the right to restrict data processing,
- e) the right to data portability
- f) the right to object to the processing of its data for the Administrator's legitimate purposes, including business activities, direct marketing of its products and services.
